Important healthcare data at your fingertips inside your Electronic Health Record (EHR) Systems represents better healthcare outcome as well as a significant time savings for clinicians. By adopting the IHE Framework standards, providers can both send and query KHIE from within their EHR to quickly access patient health information from multiple healthcare sources. This connectivity allows real-time access to aggregated clinical data: KASPER Reports (if the user is credentialed) and Medicaid Claims Data.

KASPER Reports can also be accessed via the real-time clinical data in the KHIE ePartnerViewer Provider Portal. 
